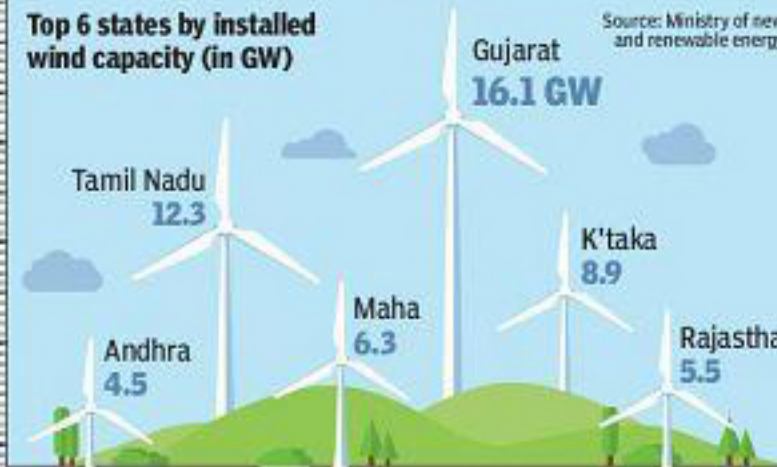
Leopard kills 86-year-old UP woman

An 86-year-old woman was killed by a leopard in Bahraich's Sujauli area early Friday, with the animal dragging the victim from her makeshift home to a nearby field. Neighbours who rushed to Phoolawati's rescue after hearing her screams saw the leopard in torchlight, but it disappeared. Around 5am, villagers found her partially eaten body in bushes near a turmeric field, around 50m from her house. Police and forest officers rushed to the spot after receiving the information. Hyderabad: Telangana HC Friday disqualified MLA Danam Nagender, who had won the Khairatabad seat on a BRS ticket in the 2023 assembly polls and later contested the Lok Sabha election on a Congress ticket.

Nagender was one of the 10 MLAs against whom BRS had approached the court for shifting loyalties after winning their seats.

Noting that he contested as a Congress candidate from Secunderabad despite being a Chief Justice APBS, a bench of Justice Justice Aresh Kumar Singh and Justice GMM Mohiuddin ruled that Nagender stood disqualified from April 23, 2024—the date when he filed his nomination for the Lok Sabha seat.

The bench rejected a request by Nagender to keep the disqualification order in abeyance, allowing him to go for an appeal. It directed the copies of the order be sent to the assembly secretary, the speaker and to Election Commission.

MLAs A Maheshwar Reddy of BJP and P Kaushik Reddy of BRS had challenged

speaker Gaddam Prasad Kumar's decision to dismiss disqualification petitions against Nagender. The HC held the speaker's findings to be "unsustainable on grounds of violation of constitutional mandates and perversity".

Exercising judicial review under Article 226, the HC ruled that the speaker committed a "serious jurisdictional error" by wrongly concluding all of Nagender's actions seen as defection by BRS had been done outside the house, and fell beyond the domain of his powers.

Nagender said he had neither resigned from BRS nor joined Congress, and there was no rule preventing an MLA from contesting a parliamentary election on the ticket of another political party.

The HC said Nagender's actions — meeting CMA A Revanth Reddy, wearing a Congress kanduwa and campaigning against BRS — "amounted to voluntarily giving up BRS membership".

US national gets default bail in terror case

New Delhi: A special NIA court in Delhi Friday granted default bail to the US national arrested in March on terror charges for allegedly helping ethnic armed groups in India and Myanmar, after the "incomplete" chargesheet filed by the investigating agency dropped charges under UAPA, reports **Koushiki Saha**.

Scot Sikh gets bail in 7 NIA cases after 9 yrs

Delhi HC Friday granted bail to British citizen Jagtar Singh Johal, who is charged with targeted killings and conspiracy linked to Khalistan Liberation Force, taking note of his "long period of incarceration" and acquittal in one of the cases. Scotland-born Johal, arrested shortly after his 2017 wedding, was named as an accused in eight cases of attempted murder in Punjab and faced UAPA charges. He was acquitted in one of the cases last year. **TNN**

While Aaron Van Dyke, who has spent 180 days in custody, the court noted NIA's failure to complete its probe. It cannot be concluded that the accused is not entitled to default bail merely because an agency says a probe is far from over, the court said.

Van Dyke had sought default bail Thursday, contending that under Section 43D(2) proviso (1) of the anti-terror law, the investigation was required to be completed within 180 days, which ended on Sept 8.

Sugar retail prices down 10% ahead of festive season, govt eases stock cap

New Delhi: Ahead of the festive season, Centre Friday relaxed the stockholding limit for bulk sugar consumers, allowing them to hold sugar for up to 30 days instead of the existing 15 days, as retail prices have eased by nearly 10% over the past three weeks.

The move comes at a time when the retail price of sugar has fallen from around Rs 65 per kg to Rs 58.5 per kg, while demand is expected to rise during the festive season.

However, the food department indicated to industry that the decline in retail prices had not kept pace with the sharp fall in ex-mill prices. It noted that while ex-mill sugar prices have dropped by nearly 25%, the benefit has not been fully passed on to consumers

through the supply chain. It urged wholesalers, retailers and other trade players to immediately pass on the price reduction to consumers.

Bulk consumers include large confectionery makers, biscuit manufacturers, soft drink and beverage companies, sweetmeat sellers and halwaais. At present, industrial users consuming more than 10 tonnes of sugar a month as

raw material are permitted to hold stocks equivalent to 15 days of consumption. The department said the limit has now been doubled to 30 days, but with a condition. Any stock held beyond the earlier 15-day limit must be sourced from sugar imported under the tariff rate quota or the advance authorisation scheme.

Centre has permitted imports of 10 lakh tonnes of sugar under the tariff rate quota and allowed domestic sale of export-bound sugar procured under the advance authorisation scheme. Sugar sourced from the domestic open market will continue to be capped at 15 days' consumption.

Govt has made it mandatory for bulk consumers to declare their sugar stocks every Friday on the food department's online portal.

Amritsar cop gunned down, 2nd in 7 months

Amritsar: In yet another targeted assassination of a cop—the second in seven months—in the border district of Amritsar, Punjab Police ASI Harjit Singh was shot dead Friday, reports **Yudhvir Rana**. He is the fourth policeman to be murdered in the state this year.

The 55-year-old was on PCR duty when he was shot point-blank. He was taken to hospital but died during treatment.

CM Bhagwant Mann announced an ex gratia of Rs 1 crore for the bereaved family. On Feb 22, ASI Gurnam Singh and home-guard jawan Ashok Kumar were shot dead while on duty in Gurdaspur district, a sensitive area close to the Pakistan border. On May 24, ASI Joga Singh was shot dead in Majitha town in Amritsar.

Caught 'cheating', IIT-B student dies by suicide

Mumbai: A second-year student of the department of energy science and engineering died by suicide at IIT Bombay Friday evening, report **V Narayan & Yogita Rao**.

According to a statement by the institute, the student was found using a mobile phone in the exam hall earlier in the day. He had uploaded the exam question paper on an AI platform to seek answers, it added.

Students gathered in large numbers demanding a detailed probe. They alleged the mental health concerns were ignored. The institute said, "No disciplinary action was initiated against the student. The instructor and the head of the department... assured him that the incident would not adversely affect his academic career."
